**June 22 Show** - Registration for Adams County 4-H members is due to the Extension Office on or before June 17 by 4:00 p.m. These forms must be turned into the Extension Office directly. Entry fee is \$10 per class, payment due morning of show, no refund on entry fees; Entry forms for out-of-county members are due to the OSU Extension Adams County, 215 N. Cross St. Room 104, West Union, OH. 45693 by 4:00 p.m. on Monday, June 17; Entry fee is \$10 per class for out-of-county 4-H members. No refund of fees. Out-of-county entries must be accompanied by a completed and signed PAS Out-of-County form:

Out-of-county forms must be signed by an Extension professional at time of entry and will be faxed back to the County Extension Office the Monday following the Show.
