**\*\*NOTE:** One form per exhibitor. 4-H: To order market chickens members must be enrolled in project *150CM-Chicken, Market*, to order market turkeys members must be enrolled in *150TM, Turkey, Market*, and to order market ducks members must be enrolled in project *150DM, Duck, Market* by February 15. FFA exhibitors must order through their FFA advisors. ***ALL market chickens, turkeys, and ducks exhibited at the 2021 Adams County Fair MUST be ordered through this process.***

I understand that only tom turkeys purchased through this process may be exhibited at the Fair. I agree to pay \$8.00 per turkey. (Minimum order is two turkeys per exhibitor. Exhibitors may exhibit a maximum of two exhibits (one turkey per exhibit). Note: Turkeys are large white toms from Cooper Farms. I understand that exhibition of poultry at the Fair may be banned by the ODA at any time pending the status of an Avian Influenza outbreak, which last occurred in 2015.

**I agree to pick up the turkey poultts at the designated date and location (on or about March 25).**

I wish to order \_\_\_\_\_ **market chicks** to exhibit in the 2021 Adams County Fair. I understand that 4-H members exhibiting market chickens **MUST be enrolled in project #150CM by February 15**. I understand that only cockerel chicks purchased through this process may be exhibited at the Fair and agree to pay \$3.50 per chick. (Minimum order is two chicks per exhibitor. Exhibitors may order as many chicks as they would like to raise, but they may exhibit a maximum of two meat pens (2 chickens per pen). I understand that exhibition of poultry at the Fair may be banned by the ODA at any time pending the status of an Avian Influenza outbreak, which last occurred in 2015.

I wish to order \_\_\_\_\_ **market ducks** to exhibit in the 2021 Adams County Fair. I understand that 4-H members exhibiting market ducks **MUST be enrolled in project #150DM by February 15**. I understand that only ducks purchased through this process may be exhibited at the Fair. I agree to pay \$5.00 per duck. (Minimum order is two ducks per exhibitor. Exhibitors may order as many ducks as they would like to raise, but they may exhibit a maximum of two exhibits (one duck per exhibit). I understand that exhibition of poultry at the Fair may be banned by the ODA at any time pending the status of an Avian Influenza outbreak, which last occurred in 2015.

**I agree to pick up the chicks and/or ducks on May 19 (unless otherwise notified) from 7-8 p.m. at the fairgrounds.**
