Another Tick to Check For

Hello, my Name is Richard Purdin with OSU Extension, Ag and Natural Resource and Community Development Educator for Adams County. I hope to better inform local producers and the public of the latest news in the world of agriculture. The second week of December has brought some welcomed dry and warmer air to the region. Hopefully, this weather trend will allow the last few corn fields to be gleaned and make feeding cattle a little more tolerable for producers. Even though winter is just starting, it will not be long that spring will be here and more of us will be spending more time outside in nature. With warmer and shorter winters and longer periods of warm and humid summers there has been a steady increase in the migration of tick species commonly associated with the southern region of the United State. The newest tick on the block is called the Gulf Coast Tick. Here are a few facts about this tick species.

- The Gulf Coast Tick was first identified in the mid 1800's in the southern coastal areas of the county.
- In the early 1900's this tick species was credited to the spread of the screw warm due to it large sized hypostome (mouth part).
- It has migrated up the Mississippi River and Ohio River valleys and has been found in Butler and Hamilton county Ohio.
- The Gulf Coast tick can travel on wildlife such as birds and prefers a similar habitat as the American Dog tick.
- This tick feeds on livestock, pets, and humans, transmitting many diseases but most commonly Hepatozoonosis in canines and Rickettsia parkeri in humans.
- Rickettsia parkeri can cause symptoms very similar to Rocky Mountain spotted fever.
- Permethrin treated clothing and spray on (for livestock) have shown good results in keeping this pest off humans and animals.
